 - d) Approve the Student and Parent Handbook

10. Receive quarterly Facility and ANE Reports from the Juvenile Probation Department staff pursuant to Title 37, Texas Administrative Code, Sec. 343.212(i).
11. Discuss and approve amendment one to the Community Supervision Cooperative Agreement between the Domestic Relations Office and the Office of the Attorney General.
12. Discuss and approve amendment two for the extension of the Travis County Integrated Child Support Cooperative Agreement between the Domestic Relations Office and the Office of the Attorney General.

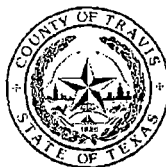
